DIRECTIONS FOR USE:

Always sort laundry loads by fabric type and soil load prior to wash. Pre-soak and/or pre-spot if necessary. Load wash machine with linens. Do not overload. Dispense product directly from shipping container into the wash cycle. Average usage is 2-6 ounces per 50 pounds of linen. Consult your service technician for exact usage addressing your water conditions and soil type.

PERSONAL PROTECTION:

EYE PROTECTION: Not required under normal use.
SKIN PROTECTION: Not required under normal use.
RESPIRATORY: Not required under normal use.

WARNING:

Causes skin irritation. Causes serious eye irritation.

PRECAUTIONARY STATEMENTS:

Wash hands thoroughly after handling. Wear protective gloves/protective clothing/eye protection/face protection.

RESPONSE/FIRST AID:

IF ON SKIN: Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Thoroughly clean clothing before reuse. Discard contaminated shoes and leather articles. Seek medical attention.

IF IN EYES: Immediately flush eyes with plenty of water for at least 15 minutes while holding eyelids apart to ensure flushing of entire surface. Do not rub eyes. Seek medical attention immediately.

IF SWALLOWED: Immediately call a physician or Poison Control Center. Do not induce vomiting. Rinse mouth with water. Dilute stomach contents by drinking water. If vomiting occurs spontaneously, keep head below hips to prevent breathing vomit. Do not give anything by mouth to an unconscious or convulsing person.

IF INHALED: Remove person to fresh air. If breathing has stopped, administer artificial respiration preferably mouth to mouth. If breathing is difficult, give oxygen. Seek medical attention.

STORAGE:

Have eyewash accessible to use in handling area. Keep containers tightly closed when not in use. Store away from acids.

DISPOSAL:

Dispose of in accordance with all Federal, State and Local pollution control regulations.
