

**HAZARD STATEMENTS:**

Causes severe skin burns and eye damage.

**PRECAUTIONARY STATEMENTS:**

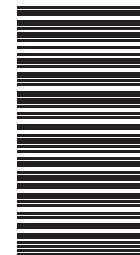

Do not use chlorine bleach in the wash cycle as it negates the enzyme activity. Either follow the wash cycle with a separate cycle for us with the chlorine bleach, or you may use an oxygen bleach in combination with the detergent in the wash cycle.
