DIRECTIONS FOR USE:

Sort laundry by fabric type and soil load. Pre-soak and/or pre-spot, if necessary. Load wash machine with linens. Do not overload. Wash with recommended amount of detergent. Do not use chlorine bleach in the wash cycle as it negates the enzyme activity. Either follow the wash cycle with a separate cycle for us with the chlorine bleach, or you may use an oxygen bleach in combination with the detergent in the wash cycle.

PERSONAL PROTECTION:

RESPIRATORY EQUIPMENT (Specify Type): Where risk assessment shows air-purifying respirators are appropriate use a full-face particle respirator type N100 (US) or type P3 (EN 143) respirator cartridges as a backup to engineering controls. Respiratory protection is not normally required.

EYE PROTECTION: Wear appropriate protective eyeglasses or chemical safety goggles as described by OSHA's eye and face protection regulations in 29 CFR 1910.133 or European Standard EN166.

PROTECTIVE GLOVES: Glove protection is not normally required.

OTHER PROTECTIVE CLOTHING: Protective garments not normally required.

ENGINEERING CONTROLS (Ventilation etc.): Use adequate ventilation to keep airborne concentrations low.

Work/Hygienic/Maintenance Practices: Handle in accordance with good industrial hygiene and safety practice.

Wash hands before breaks and at the end of workday.

DANGER:

Causes severe skin burns and eye damage. Causes serious eye irritation.

PRECAUTIONARY STATEMENTS:

Wash hands thoroughly after handling. Wear protective gloves and eye protection.

RESPONSE/FIRST AID:

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting.

IF ON SKIN (or hair): Remove/take off immediately all contaminated clothing. Rinse skin with water/shower.

IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing.

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Call a poison control center or physician for treatment advice. Have product container or label with you when calling poison control center or physician. Immediately call a POISON CENTER or doctor/physician. If eye irritation persists, get medical advice/attention. Wash contaminated clothing before reuse.

STORAGE & DISPOSAL: Store locked up. Unused product is not a RCRA Hazardous waste. However, contaminated product and wastes may be RCRA hazardous. Users are advised to determine the appropriate disposal method based on local, state and federal regulations and comply with those regulations.
