

## **DIRECTIONS FOR USE:**

#### TOILETS:

- 1. **Apply** 3-WAY behind and under the inside lips where water outlets are located.
- 2. **Swab or scrub** inside of drain pipe. Flush.
- 3. Rinse entire fixture with cold water.

#### **TUBS AND SHOWERS:**

- 1. Apply diluted 3-WAY to Surface. Dilute 1 part 3-WAY to 3 parts water.
- Swab or scrub surface.
- 3 Rinse with cold water.
