

CHEWING GUM REMOVER

USE INFORMATION

For removal of chewing gum on carpets, floors, cement, furniture, tables and clothing.



DIRECTIONS FOR USE:

1. **SPRAY** directly on gum until it is completely frozen. Once gum is frozen it loses its adhering tack and can be scraped away with a knife or spatula.

DANGER

EXTREMELY FLAMMABLE AEROSOL. CONTENTS UNDER PRESSURE.

Prevention

Contact with liquid may freeze tissue, similar to thermal burn. Obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Do not spray on an open flame or other ignition source. Pressurized container: Do not pierce or burn, even after use. Wear protective gloves / protective clothing / eye protection / face protection.

Response

Storage

Store locked up. Protect from sunlight. Do not expose to temperatures exceeding $50^{\rm o}$ C / $122^{\rm o}$ F.
